



Overview

3. Martin Luther's Break with the Catholic Church

The 95 Theses (1517)

On October 31, 1517, Martin Luther famously nailed his 95 Theses to the door of the Castle Church in Wittenberg (though some historians debate this event's literal occurrence). This document was a list of propositions criticizing Church practices, particularly the sale of indulgences.

Main Points of the 95 Theses:

- Salvation comes by faith alone (Sola Fide).
- The Bible alone (Sola Scriptura) is the ultimate authority in matters of faith.
- The Pope has no power to absolve sins or grant indulgences.
- Christians should focus on genuine repentance and spiritual growth.

The 95 Theses were quickly translated from Latin into German, printed, and spread throughout Europe, fueling widespread public debate.

Confrontation with the Catholic Church

The Catholic Church reacted strongly to Luther's challenges. In 1520, Pope Leo X issued a papal bull (Exsurge Domine) demanding Luther recant 41 of his statements or face excommunication. Luther publicly burned the papal bull, symbolizing his defiance.

In 1521, Luther was summoned before the Diet of Worms, a formal assembly of the Holy Roman Empire led by Emperor Charles V. Asked to recant his writings, Luther famously declared:

"Here I stand; I can do no other. God help me."

Luther was declared an outlaw and a heretic, and his works were banned.

However, he was secretly taken to Wartburg Castle by Prince Frederick the Wise, where he lived in hiding and began translating the New Testament into German.

4. Theological Contributions

Key Doctrines of the Reformation

1. Sola Scriptura (Scripture Alone): The Bible is the only authoritative source of God's word.
2. Sola Fide (Faith Alone): Salvation comes through faith alone, not through Church rituals or works.
3. Sola Gratia (Grace Alone): Salvation is a gift from God, not something earned.
4. Solus Christus (Christ Alone): Christ is the only mediator between God and humanity.
5. Soli Deo Gloria (Glory to God Alone): All glory belongs to God, not the Church or its leaders.
